#### NOTICE OF POSTAL BALLOT

**NOTICE** is hereby given to the Members of Elgi Rubber Company Limited ("the Company") pursuant to Section 108 and 110 of the Companies Act, 2013 ("**Act**") and Rule 20 and 22 of the Companies (Management and Administration) Rules, 2014 (the "**Rules**") read with Regulation 44 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("**Listing Regulations**") and General Circular No.11/2022 dated December 28, 2022 read with the relevant circular(s) issued during the year(s) 2020, 2021 and 2022 respectively by the Ministry of Corporate Affairs (hereinafter collectively referred to as "**MCA Circulars**") andthe Secretarial Standards on General Meetings ("**SS-2**") issued by the Institute of Company Secretaries of India and all other applicable laws, rules and regulations (including any statutory modification(s) or amendment(s) or re-enactment(s) thereof for the time being in force and as amended from time to time), that the following resolution (as indicated herein below) proposed to be passed through Postal Ballot by way of voting through electronic means ("**remote e-voting**") only.

Pursuant to the aforesaid MCA and SEBI Circular(s) and pursuant to the provisions of Section 110 and other applicable provisions, if any, of the Companies Act, 2013 and the relevant Rules made thereunder, the Company will send this Postal Ballot Notice by email to all its shareholders, who have registered their email addresses with the Company or depository/depository participants and the communication of assent/dissent by the members will only take place through remote e-voting process. This Postal Ballot is accordingly being initiated in compliance with the above said Circulars.

In compliance with the requirements of the MCA and SEBI Circular(s), the hard copy of this Postal Ballot Notice along with Postal Ballot Forms and pre-paid business envelope will not be sent to the shareholders and hence, the shareholders are requested to communicate their assent or dissent through remote e-voting process only.

The Board of Directors of the Company, vide their resolution passed on March 20, 2023, has appointed R Jeyachandran, FCA, ACS, Partner of M/s. RJC Associates, Chartered Accountants, Coimbatore as the Scrutinizer for conducting the Postal Ballot voting through electronic means in a fair and transparent manner and for ascertaining the requisite majority in compliance with Rule 22(5) & (6) of the Companies (Management and Administration) Rules, 2014.

Pursuant to Regulation 44 of the Listing Regulations and pursuant to the provisions of Sections 108 and 110 of the Companies Act, 2013 read with the relevant Rules and the MCA and SEBI Circular(s), the Company has provided electronic voting ("e-voting") facility only.

The Company has engaged the services of Link Intime India Private Limited ("LIIPL") to provide e-voting facility to the Members of the Company through their Instavote platform (<u>https://instavote.linkintime.co.in</u>). The following statements sets out the material facts relating to the special business mentioned under Item No.1 in the accompanying Postal Ballot Notice dated March 20, 2023 and shall be taken as forming part of the Notice:

#### Item No.1

As a part of strategic steps of restructuring the business operations, the Company intends to sell or otherwise dispose of certainimmovable properties, comprising of land and buildings, as detailed in the Resolution set out under Item No.1 above, being its non-core assets, with an intent to reduce its debts. The consideration to be received on the said sale of properties would be utilized in paying off the Company's long/short term debts and other business requirements. Further, the Company is in the process of identifying potential buyer(s) and negotiating the consideration and other terms & conditions of the said arrangement.

In view of the same, the Board of Directors, at their meeting held on March 20, 2023, has considered that the above properties may be 'substantial'in terms of Section 180 (1) (a) of the Companies Act, 2013 and hence, it has approved to sell or otherwise dispose of the properties, as mentioned in the special resolution set out under Item No.1 above, subject to obtaining the approval of the shareholders of the Company by means of passing a special resolution under Section 180(1)(a) passed through postal ballot means pursuant to Section 110 of the Companies Act, 2013 and subject to obtaining such other approvals, consents, permissions and sanctions as may be necessarily required from the appropriate authorities in this regard.
