Responsibility of the Management

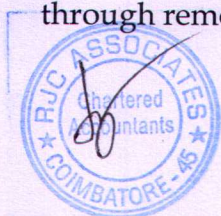


Further, in addition to the above, I submit my report as under:

- The Postal Ballot Notice dated March 20, 2023 along with necessary statement setting out the material facts under Section 102 of the Companies Act, 2013 were sent on Wednesday, April 05, 2023 by the Registrar & Share Transfer Agent (RTA) viz., M/s. Link Intime India Private Limited ("LI IPL") through electronic mail to those members whose names appeared in the Register of Members / List of Beneficiaries as on Friday, March 31, 2023 ("cut-off date") and who had registered their email ID with the Company / RTA / Depositories in compliance with the MCA Circulars. The Company has also placed the notice of the Postal Ballot on its website.
- The shareholders of the Company holding shares as on the "cut-off" date on Friday, March 31, 2023 were entitled to vote on the proposed resolution as set out in Item No. 1 of the said Postal Ballot Notice.
- The remote e-voting period remained open from Thursday, April 06, 2023, 09:00 AM (IST) to Friday, May 05, 2023, 05:00 PM (IST) (both days inclusive). During the said period, the members of the Company holding shares in physical and / or in dematerialized form, as on the cut-off date i.e. March 31, 2023 were entitled to vote on the resolution set out in the Notice of Postal ballot through remote e-voting.




