Code of Conduct for Directors and Senior Management

Applicability:

The Code of Conduct shall apply to:

- i. All Directors of the Company, whether executive or non-executive including nominee directors:
- ii. All Senior Management Executives.

Senior Management Executives shall include:

- i. All executives of the Company from the rank of General Manager and above; and
- ii. All employees of the Company, reporting directly to the Managing Director/ Manager/Executive Director(s) irrespective of their grade.

The Code comes into immediate effect.

Scope:

The Board of Directors (the Board) and the Senior Management of the Company agree to abide by the following Code of Conduct:

- i. Attend Board/ Shareholders / Committee / Senior management meetings and seek prior leave for absence from such meeting/s.
- ii. Exercise authority and power with due care and diligence and whilst discharging the fiduciary responsibility of office in the best interest of the Company and all the stake holders.
- iii. Not allow personal interest to conflict with the interest of the Company or to come in the way of discharge of duties of office.
- iv. Abide by policies and business principles of the Company.
- v. Comply with all applicable laws, rules and regulations.
- vi. Preserve and protect the environment with due concern for ecology, clean air and meet high levels of pollution and emission standards.
- vii. Observe strict confidentially of the information acquired in the course of discharge of duties of office and not use the same for any personal purpose or advantage.

- viii. Use Company property only for official purpose and for no personal gain. Not accept any personal gratification from suppliers/service providers/business partners, etc. (Note: Personal gratification will not include normal entertainment and gifts of no significant value).
- ix. Deal fairly with customers, suppliers, employees and other business partners.
- x. Respect safety and health of all employees and provide working conditions which are not harmful to health.
- xi. Encourage employees to acquire skills, knowledge and training to expand/enhance their professional and specialized knowledge.
- xii. Provide equal opportunities to all employees and aspirants for employment in the Company irrespective of gender, caste, religion, race or color, merit being the sole differentiating factor.
- xiii. Conduct business operations in compliance with competition laws and principles of fair market competition.
- xiv. Maintain high ethical and professional standards in all dealings.
- xv. Not to conduct ownselves in a manner as may bring disrepute to office or tarnish the reputation and image of the Company.
- xvi. Not take up any activities competing with the business of the Company.
- xvii. Make proper record of all financial transactions and not create undisclosed or unrecorded account / fund or asset.
- xviii. Report any violation of this Code of Conduct to any of the Whole-time Directors of the Company.
- xix. Co-operate with Government, Trade and Industry Associations for and in the development of economic legislations concerning the business of the Company.

Duties Of Independent Directors

(Pursuant to section 149, section 166 and Schedule IV of the Companies Act, 2013)

Guidelines of professional conduct:

An independent director shall;

- i. uphold ethical standards of integrity and probity;
- ii. act objectively and constructively while exercising his duties;
- iii. exercise his responsibilities in a bona fide manner in the interest of the company;
- iv. devote sufficient time and attention to his professional obligations for informed and balanced decision making;

- v. not allow any extraneous considerations that will vitiate his exercise of objective independent judgment in the paramount interest of the company as a whole, while concurring in or dissenting from the collective judgment of the Board in its decision making;
- vi. not abuse his position to the detriment of the company or its shareholders or for the purpose of gaining direct or indirect personal advantage or advantage for any associated person;
- vii. refrain from any action that would lead to loss of his independence;
- viii. where circumstances arise which make an independent director lose his independence, the independent director must immediately inform the Board accordingly;
- ix. assist the company in implementing the best corporate governance practices.

Role and functions:

The independent directors shall:

- help in bringing an independent judgment to bear on the Board's deliberations especially on issues of strategy, performance, risk management, resources, key appointments and standards of conduct;
- ii. bring an objective view in the evaluation of the performance of board and management;
- iii. scrutinize the performance of management in meeting agreed goals and objectives and monitor the reporting of performance;
- iv. satisfy themselves on the integrity of financial information and that financial controls and the systems of risk management are robust and defensible;
- v. safeguard the interests of all stakeholders, particularly the minority shareholders;
- vi. balance the conflicting interest of the stakeholders;
- vii. determine appropriate levels of remuneration of executive directors, key managerial personnel and senior management and have a prime role in appointing and where necessary recommend removal of executive directors, key managerial personnel and senior management;
- viii. moderate and arbitrate in the interest of the company as a whole, in situations of conflict between management and shareholder's interest.

Duties

The Independent directors shall

 undertake appropriate induction and regularly update and refresh their skills, knowledge and familiarity with the company;

- ii. seek appropriate clarification or amplification of information and, where necessary, take and follow appropriate professional advice and opinion of outside experts at the expense of the company;
- iii. strive to attend all meetings of the Board of Directors and of the Board committees of which he is a member;
- iv. participate constructively and actively in the committees of the Board in which they are chairpersons or members;
- v. strive to attend the general meetings of the company;
- vi. where they have concerns about the running of the company or a proposed action, ensure that these are addressed by the Board and, to the extent that they are not resolved, insist that their concerns are recorded in the minutes of the Board meeting;
- vii. keep themselves well informed about the company and the external environment in which it operates;
- viii.not to unfairly obstruct the functioning of an otherwise proper Board or committee of the Board:
- ix. pay sufficient attention and ensure that adequate deliberations are held before approving related party transactions and assure themselves that the same are in the interest of the company.
- x. ascertain and ensure that the company has an adequate and functional vigil mechanism and to ensure that the interests of a person who uses such mechanism are not prejudicially affected on account of such use;
- xi. report concerns about unethical behaviour, actual or suspected fraud or violation of the company's code of conduct or ethics policy:
- xii. acting within his authority, assist in protecting the legitimate interests of the company, shareholders and its employees;
- xiii. not disclose confidential information, including commercial secrets, technologies, advertising and sales promotion plans, unpublished price sensitive information, unless such disclosure is expressly approved by the Board or required by law.

SEPARATE MEETINGS:

- i. The independent directors of the company shall hold at least one meeting in a year, without the attendance of non-independent directors and members of management;
- ii. All the independent directors of the company shall strive to be present at such meeting;
- iii. The meeting shall:
 - i. review the performance of non-independent directors and the Board as a whole;

- ii. review the performance of the Chairperson of the company, taking into account the views of executive directors and non-executive directors;
- iii. assess the quality, quantity and timeliness of flow of information between the company management and the Board that is necessary for the Board to effectively and reasonably perform their duties.

General duties of directors pursuant to section 166 of the companies act, 2013:

- i. Subject to the provisions of the Companies Act, 2013, a director of a company shall act in accordance with the articles of the company.
- ii. A director of a company shall act in good faith in order to promote the objects of the company for the benefit of its members as a whole, and in the best interests of the company, its employees, the shareholders, the community and for the protection of environment.
- iii. A director of a company shall exercise his duties with due and reasonable care, skill and diligence and shall exercise independent judgment.
- iv. A director of a company shall not involve in a situation in which he may have a direct or indirect interest that conflicts, or possibly may conflict, with the interest of the company.
- v. A director of a company shall not achieve or attempt to achieve any undue gain or advantage either to himself or to his relatives, partners, or associates and if such director is found guilty of making any undue gain, he shall be liable to pay an amount equal to that gain to the company.
- vi. A director of a company shall not assign his office and any assignment so made shall be void.

Compliance with laws, rules, and regulations:

The Directors, officers and employees shall comply with all applicable laws, rules, and regulations. An employee of a company and his immediate family shall not derive any benefit or assist others to derive any benefit from the access to and possession of information about the company, which is not in the public domain and thus constitutes insider information. Insider trading rules are strictly enforced, even in instances when the financial transactions seem small. The Company has imposed a trading blackout period on members of the Board of Directors, executive officers and all employees who, as a consequence of their position with the Company, are more likely to be exposed to material nonpublic information about the Company. These directors, executive officers and employees generally may not trade in Company securities during the blackout period.
