- The Postal Ballot Notice dated February 09, 2024 along with necessary statement setting out the material facts under Section 102 of the Companies Act, 2013 were sent on Wednesday, February 21, 2024 by the Registrar & Share Transfer Agent (RTA) viz., M/s. Link Intime India Private Limited ("LIIPL") through electronic mail to those members whose names appeared in the Register of Members / List of Beneficiaries as on Friday, February 16, 2024 ("cut-off date") and who had registered their email ID with the Company / RTA / Depositories in compliance with the MCA Circulars.
